Tree Pruning Day Recap

Bucklin gave an overview of the tree pruning day completed in September. Trees at the corner of County Road 1 and 3rd Avenue were discussed. There have been some complaints from semi-

drivers that it is difficult to see looking westward when stopped at the stop sign. The solution may be to take out the trees and replant new ones somewhere on the property.

City Food Forest

Harder expressed concerns about the maintenance of the food forest. The area has weeds and is not properly maintained throughout the year. It was discussed to schedule a time next year in the spring to maintain the area, so vegetation can properly grow.

The meeting was called to order at 7:00 a.m.

Approval of Minutes and Bills

Motion by Lohrenz, seconded by Johnson, to add 6.F Land Negotiations (meeting may be closed as allowed in MN Statutes 13D.05 Subd. 3) and check numbers 01857 - 018616 to the consent agenda. Motion carried. Motion by Lohrenz, seconded by Johnson to approve the agenda, December 13 Minutes, and Check Numbers 018587 – 018616. Motion carried.

Electric Department

Ron Melson, Electric Superintendent, reported that the lights at the commercial park have been worked on and installed. Dave and Lane have started the lineman program with Northwest Line College which is tied with MMUA. The substation project has not been fully completed. Melson has investigated the issue and discovered that the engineer and contractor for the project are the same engineer and contractor for the substation project in Windom. There are some disputes between the engineer and contractor for the Windom project causing delays for the Mountain Lake project. Direction was given to the city administrator to write up a letter with the assistance of the city attorney to encourage both to resolve the issues and finish up Mountain Lake's substation project.

Water/Wastewater Department

Dave Watkins reported that the RO sensors at the water plant will be installed next month and that a water main was fixed.

Office

An error in billing large commercial and rural large commercial electric users was discovered this past week. The approved 2018 demand charge of \$10.55 per kW was not updated in the billing system from the 2017 rate of \$8.75 per kW. Each account affected has been undercharged for 11 months. Utilities Office Manager Lynda Cowell is working on the corrected amounts for each account in this category. According to state statute 216B.098 Subd. 4,

A utility shall offer a payment agreement to customers who have been undercharged if no culpable conduct by the customer or resident of the customer's household caused the undercharge. The agreement must cover a period equal to the time over which the undercharge occurred or a different time period that is mutually agreeable to the customer and the utility, except that the duration of a payment agreement offered by a utility to a customer whose household income is at or below 50 percent of state median household income must consider the financial circumstances of the customer's household.

- (b) No interest or delinquency fee may be charged as part of an undercharge agreement under this subdivision.
- (c) If a customer inquiry or complaint results in the utility's discovery of the undercharge, the utility may bill for undercharges incurred after the date of the inquiry or complaint only if the utility began investigating the inquiry or complaint within a reasonable time after when it was made.

Rates, users, amounts, and billing were discussed. <u>Motion by Janzen, seconded by Lohrenz, to agree to divide the total amount for each account to be paid off over 11 months in 2019.</u> The office will work on sending each account affected a letter explaining the error and writing out an agreement to pay the undercharged amount and abiding by statute 216B.098.

Water/Wastewater Superintendent

City Administrator Schulte met with Mark Langland, Dean Janzen, and Dave Watkins to discuss the dynamics of the Water/Wastewater department. Options for the department were discussed. St. James and Windom, while larger cities, have a superintendent, foreman, and 2-3 workers in their departments. Lakefield, a smaller city than Mountain Lake, contracts with PeopleService for a 40-hour worker/week for their wastewater department with the required licenses for around \$150,000 a year. The pay scale for a foreman in Windom and St. James would be similar to a pay rate between Mountain Lake's Public Works I and Public Works II positions. The decision to be brought to the Utilities Commission was to begin the process of creating a new Water/Wastewater Foreman position for the department. This position would include similar duties as the superintendent minus the license requirements and other responsibilities. If approved to begin the process of creating a new position, city administrator Schulte will begin drafting the job description and pay scale and meet with Keith Ferrington, AFSCME Labor Representative to seek the union's approval. The description and pay scale would be brought back to the commission to then recommend to the city council to approve. Dave Watkins discussed that a potential agreement to utilize his current licenses could be made that would include about 2 hours of work/week to fulfill the two department's license requirements and

around 2 days/month of training/supervision. <u>Motion by Janzen, seconded by Johnson, to begin the process of creating a Water/Wastewater Foreman position. Motion carried.</u>

Bond Payment Information

Mountain Lake Municipal Utilities bond payments were presented and explained by the city administrator. The presented graph includes the bond name, department, payments until, and payment amounts. The Electric Department has bonds expiring in 2023 and 2024. When these expire, the amounts for the NESHAP/sub-station bond will increase to pay more each year and will also keep the bond payments stable for budgeting purposes. Bond payments, projects, and timetables were discussed. The information presented was for informational purposes only and to understand the various bond payments and their timelines.

Surrounding Cities Fund Transfers Information

The city of Windom conducted a study of various cities requesting information on how much money is transferred from utilities or other miscellaneous sources of revenue to the city budget. Two graphs were presented that included only utilities and the other with miscellaneous sources. Based on dollar per person that is transferred to the city, Mountain Lake sits at \$57.03 per person. Sleepy Eye was the highest at \$175.09 per person. The average of the 19 cities listed was \$86.49 per person. The information presented was for informational purposes only and to learn what other cities transfer to the city budget.

Chamber Donation

Mountain Lake Chamber of Commerce recently sent out letters to renew chamber membership dues for 2019. Rates for platinum membership increased from \$812/year to \$837/year. MLMU also gave an extra donation of \$1,140 last year. Motion by Lohrenz, seconded by Johnson, to stay platinum members and donate \$1,140 again for 2019. Motion carried.

SUZLON Monthly Report

The November report was reviewed. An end of the year report from SUZLON will be sent this upcoming spring.

Land Negotiations (meeting may be closed as allowed in MN Statutes 13D.05 Subd. 3) Motion by Lohrenz, seconded by Janzen, to close the public meeting at 8:01 a.m. Motion by Lohrenz, seconded by Johnson, to open the public meeting at 8:12 a.m. Motion carried. No action taken.

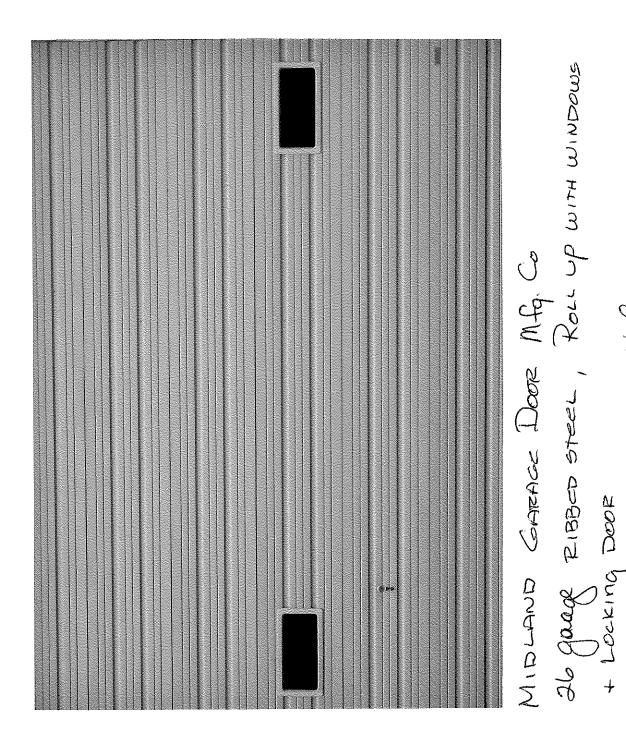

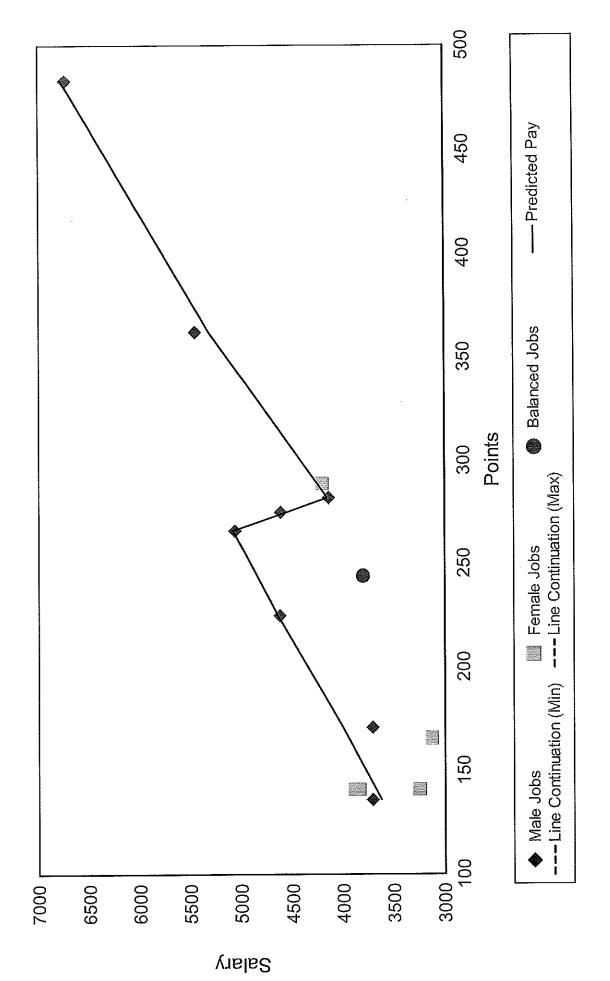

The following was published from The League of Minnesota Cities. The following policies have been updated and follow templates to abide by the MGDPA. These policies will need Council approval each year before August 1st.

Reminder: Cities Required to Establish Written Data Access Policies

Cities need to adopt written policies and procedures to ensure that requests for data are received and responded to promptly and appropriately. (Published Dec 17, 2018)

With a recent rise in lawsuits regarding data access issues, the League is encouraging all cities to review their data practices policies to ensure they meet state requirements.

The Minnesota Government Data Practices Act (MGDPA) is a series of state laws that attempt to balance the public's right to know what its government is doing, an individual's right to privacy, and the government's need to function responsibly and efficiently.

Need for policies

One key aspect of the MGDPA is the need to establish written procedures to ensure that requests for government data are received and responded to promptly and appropriately.

Under the MGDPA, a city must establish a written Public Data Access Policy to ensure that requests for government data are received and responded to promptly and appropriately. In addition, a city must establish a written Data Subject Rights and Access Policy explaining the rights of data subjects and the specific procedures used by a city for access by the data subject to public or private data on individuals.

Both policies need to be updated no later than Aug. 1 of each year to reflect changes in personnel or other circumstances that might affect public access to government data. Failure to establish these procedures is a violation of the MGDPA.

If your city has not adopted these policies, it should do so right away. In addition, if your city has not updated its policies in the last year, it needs to review the policies to comply with the MGDPA.



Data Practices Policy: City of Mountain Lake

Data Practices Policy For the Public

Minnesota Statutes, sections 13.025 and 13.03 require this policy.

Your Right to See Public Data

The Government Data Practices Act (Minnesota Statutes, Chapter 13) presumes that all government data are public unless a state or federal law says the data are not public. Government data means all recorded information a government entity has, including paper, email, flash drives, CDs, DVDs, photographs, etc.

The law also says that the Department of Administration ("Admin") must keep all government data in a way that makes it easy for you to access public data. You have the right to look at (inspect), free of charge, all public data that we keep. You also have the right to get copies of public data. The Data Practices Act allows us to charge for copies. You have the right to look at data, free of charge, before deciding to request copies.

How to Request Public Data

You can ask to look at (inspect) data at our office or ask for copies of public data that we keep. Data requests must be in writing, and must be mailed or emailed to Admin's Data Practices Compliance Official ("DPCO") or another appropriate designee listed in the Data Practices Contacts on page 4. If you have any questions about making a data request, contact our DPCO.

We recommend using the sample **Data Request Form – Members of the Public** on page 6. If you do not use the data request form, your request should:

- Say that you are making a request for public data under the Government Data Practices Act (Minnesota Statutes, Chapter 13).
- Include whether you would like to inspect the data, have copies of the data, or both.
- Provide a clear description of the data you would like to inspect or have copied.

You are not required to identify yourself or explain the reason for your data request. However, you may need to provide us with some personal information for practical reasons (for example: if you want us to mail copies to you, you need to provide us with an address or P.O Box). If we do not understand your request and have no way to contact you, we cannot respond to your request.

How We Will Respond to Your Data Request

Upon receiving your request, we will review it.

- · We may ask you to clarify what data you are requesting.
- If we do not have the data, we will tell you as soon as reasonably possible.
- If we have the data, but we are not allowed to give it to you, we will tell you as soon as reasonably possible and identify the law that prevents us from providing the data.
- If we have the data, and the data are public, we will respond to your request appropriately and promptly, within a reasonable amount of time by doing one of the following:
 - o Arrange a date, time, and place for you to inspect the data at our offices; or

- o Tell you the amount you owe for copy costs, and then provide you with copies of the data as soon as reasonably possible after you pay them. You may choose to pick up your copies, or we will mail or email them to you. We will provide electronic copies (such as email or CD-ROM) upon request, if we keep the data in that format and we can reasonably make a copy.
- o Response time may be impacted by the size and/or complexity of your request, and also by the number of requests you make in a given period of time.
- If you do not arrange to inspect the data or pay for the copies within 10 business days after we tell you
 the data are ready, we will conclude that you no longer want the data and will consider your request
 closed.

If you do not understand some of the data (technical terminology, abbreviations, or acronyms), please tell the person who provided the data to you. We will give you an explanation if you ask.

The Data Practices Act does not require us to create or collect new data in response to a data request, or to provide data in a specific form or arrangement if we do not keep the data in that form or arrangement. For example, if the data you request are on paper only, we are not required to create electronic documents to respond to your request. If we agree to create data in response to your request, we will work with you on the details of your request, including cost and response time.

We are also not required to respond to questions that are not about your data requests, or requests for government data.

Requests for Summary Data

Summary data are statistical records or reports created by removing identifying information about individuals from entirely private or confidential data. We will create summary data if you request it in writing and pre-pay for the cost of creating the data.

You may use the data request form on page 8 to request summary data. We will respond to your request within ten business days with the data or details of when the data will be ready and how much we will charge you.

Copy Costs - When You Request Public Data

We charge for copies of government data when the total charges are \$5.00 or more. Minnesota Statutes, section 13.03, subdivision 3(c) allows us to charge for copies. Multiple requests made within the same 10 business-day period will be treated as a single request, for the purposes of calculating whether the \$5.00 minimum is met. Copy costs must be paid in full before Admin will provide the requested copies. Multiple requests made within the same 10 business-day period will be treated as a single request for the purposes of calculating total copy costs.

For 100 or fewer paper copies - 25 cents per page

100 or fewer pages of black and white, letter or legal size paper copies cost 25¢ for a one-sided copy, or 50¢ for a two-sided copy.

Most other types of copies - actual cost

The charge for most other types of copies, when a charge is not set by statute or rule, is the actual cost of searching for and retrieving the data, and making the copies or electronically sending the data.

In determining the actual cost of making copies, we include employee time, the cost of the materials onto which we are copying the data (paper, CD, DVD, etc.), and mailing costs (if any). If your request is for copies of data that we cannot copy ourselves, such as photographs, we will charge you the actual cost we must pay an outside vendor for the copies.

If, based on your request, we find it necessary for a higher-paid employee to search for and retrieve the data, we will calculate search and retrieval charges at the higher salary/wage.

If possible, and upon request, we will provide you with an estimation of the total cost of supplying copies.

Data Practices Policy: City of Mountain Lake

Requests for Data About You and Your Rights as a Data Subject

Minnesota Statutes, sections 13.025 and 13.03 require this policy.

What is a "Data Subject"?

When government has information recorded in any form (paper, harddrive, voicemail, video, email, etc.), that information is called "government data" under the Government Data Practices Act (Minnesota Statutes, Chapter 13). When we can identify you in government data, you are the "data subject" of that data. The Data Practices Act gives you, as a data subject, certain rights. This policy explains your rights as a data subject, and tells you how to request data about you, your minor child, or someone for whom you are the legal guardian.

When Admin Has Data About You

The City of Mountain Lake has data on many people, such as employees, job applicants, vendors, etc. We can collect and keep data about you only when we have a legal purpose to have the data. Admin must also keep all government data in a way that makes it easy for you to access data about you.

Government data about an individual have one of three "classifications." These classifications determine who is legally allowed to see the data. Data about you are classified by state law as public, private, or confidential. Here are some examples:

Public Data

The Data Practices Act presumes that all government data are public unless a state or federal law says that the data are not public. We must give public data to anyone who asks. It does not matter who is asking for the data or why the person wants the data. The following are examples of public data about you that we might have:

The following is are examples of public data about you: Your name on an application for a license from the city or the names of all City of Mountain Lake employees.

Private data

We cannot give private data to the general public. We can share your private data with you, with someone who has your permission, with our government entity staff whose job requires or permits them to see the data, and with others as permitted by law or court order. The following is an example of private data about you that we might have:

The following is an example of private data about you: Social Security Numbers.

Confidential Data

Confidential data have the most protection. Neither the public nor you can access confidential data even when the confidential data are about you. We can share confidential data about you with our government entity staff

who have a work assignment to see the data, and to others as permitted by law or court order. The following is an example of confidential data about you:

The following is an example of confidential data about you: *The identity of the subject of an active criminal investigation*.

Your Rights Under the Government Data Practices Act

As a data subject, you have the following rights.

Access to Your Data

You have the right to look at (inspect), free of charge, public and private data that we keep about you. You also have the right to get copies of public and private data about you. The Data Practices Act allows us to charge for copies. You have the right to look at data, free of charge, before deciding to request copies.

Also, if you ask, we will tell you whether we keep data about you and whether the data are public, private, or confidential.

As a parent, you have the right to look at and get copies of public and private data about your minor children (under the age of 18). As a legally appointed guardian, you have the right to look at and get copies of public and private data about an individual for whom you are appointed guardian.

Minors have the right to ask us not to give data about them to their parent or guardian. If you are a minor, we will tell you that you have this right. We will ask you to put your request in writing and to include the reasons that we should deny your parents access to the data. We will make the final decision about your request based on your best interests.

When We Collect Data From You

When we ask you to provide data about yourself that are not public, we must give you a notice called a Tennessen warning. The notice controls what we do with the data that we collect from you. Usually, we can use and release the data only in the ways described in the notice.

We will ask for your written permission if we need to use or release private data about you in a different way, or if you ask us to release the data to another person. This permission is called informed consent.

If you want us to release data to another person, you must use the consent form we provide.

Protecting Your Data

The Data Practices Act requires us to protect your data. We have established appropriate safeguards to ensure that your data are safe.

In the unfortunate event that we determine a security breach has occurred and an unauthorized person has gained access to your data, we will notify you as required by law.

When Your Data are Inaccurate or Incomplete

You have the right to challenge the accuracy and/or completeness of public and private data about you. You also have the right to appeal our decision. If you are a minor, your parent or guardian has the right to challenge data about you.

How to Make a Request For Your Data

You can ask to look at (inspect) data at our office, or ask for copies of data that we have about you, your minor child, or an individual for whom you have been appointed legal guardian.

Make a written request. You may make your request by mail, fax, email, or in person during City Hall hours to the Data Practices Compliance Officer, using the data request form on page

We recommend using the sample **Data Request Form – Data Subjects** on page 8. If you do not choose to use the data request form, your request should:

- Say that you are making a request as a data subject, for data about you (or your child, or person for whom you are the legal guardian), under the Government Data Practices Act (Minnesota Statutes, Chapter 13).
- Include whether you would like to inspect the data, have copies of the data, or both.
- Provide a clear description of the data you would like to inspect or have copied.
- Provide proof that you are the data subject or data subject's parent/legal guardian.

We require proof of your identity before we can respond to your request for data. If you are requesting data about your minor child, you must show proof that you are the minor's parent. If you are a legal guardian, you must show legal documentation of your guardianship. Please see the Standards for Verifying Identity on page 9. If you do not provide proof that you are the data subject, we cannot respond to your request.

How We Respond to a Data Request

Upon receiving your request, we will review it.

- We may ask you to clarify what data you are requesting.
- We will ask you to confirm your identity as the data subject.

If we do not have the data, we will notify you in writing within 10 business days.

- If we have the data, but the data are confidential or not public data about someone else, we will notify you within 10 business days and identify the law that prevents us from providing the data.
- If we have the data, and the data are public or private data about you, we will respond to your request within 10 business days by doing one of the following:
 - o Arrange a date, time, and place to inspect data in our offices, for free, or
 - Provide you with the data within 10 business days. You may choose to pick up your copies, or we
 will mail or fax them to you. We will provide electronic copies (such as email or CD-ROM) upon
 request if we keep the data in electronic format

We will provide notice to you about our requirement to prepay for copies.

Following our response, if you do not make arrangements within 10 business days to inspect the data or pay for the copies, we will conclude that you no longer want the data and will consider your request closed.

• After we have provided you with your requested data, we do not have to show you the same data again for 6 months unless there is a dispute about the data or we collect or create new data about you.

If you do not understand some of the data (technical terminology, abbreviations, or acronyms), please tell the person who provided the data to you. We will give you an explanation if you ask.

The Data Practices Act does not require us to create or collect new data in response to a data request, or to provide data in a specific form or arrangement if we do not keep the data in that form or arrangement. For example, if the data you request are on paper only, we are not required to create electronic documents to respond to your request. If we agree to create data in response to your request, we will work with you on the details of your request, including cost and response time.

In addition, we are not required to respond to questions that are not about your data requests, or that are not requests for government data.

Minnesota Statutes, section 13.04, subdivision 3 allows us to charge for copies.

You must pay for the copies before we will give them to you.

We do not charge for copies if the request is less than 20 pages.

Actual Cost of Making the Copies

We will charge the actual cost of making copies for data about you. In determining the actual cost, we include the employee-time to create and send the copies, the cost of the materials onto which we are copying the data (paper, CD, DVD, etc.), and mailing costs such as postage (if any).

If your request is for copies of data that we cannot copy ourselves, such as photographs, we will charge you the actual cost we must pay an outside vendor for the copies.

The cost of employee time to make copies is \$25.00 per hour.

Copy Charges Set by Ordinance = \$0.25 per page

We do not charge for other types of copies if the cost is less than \$5.00

 - o the foreign equivalent of any of the above
- The parent or guardian of a minor must provide a valid photo ID and either
 - o a certified copy of the minor's birth certificate or
 - a certified copy of documents that establish the parent or guardian's relationship to the child,
 such as
 - a court order relating to divorce, separation, custody, foster care
 - a foster care contract
 - an affidavit of parentage
- The legal guardian for an individual must provide a valid photo ID and a certified copy of appropriate documentation of formal or informal appointment as guardian, such as
