# Notification of Accessibility of the Service Line Materials Inventory

## **City of Mountain Lake**

The City of Mountain Lake has completed and submitted our service line materials inventory to the Minnesota Department of Health. The service line inventory is publicly available, and you can check the materials for your service line by visiting the Lead Inventory Tracking Tool (LITT) at <a href="https://maps.umn.edu/LSL/">https://maps.umn.edu/LSL/</a> you may also contact us at 507-822-2181. To complete the service line inventory our system performed record review, community outreach, and/or visual inspections.

As of October 16, 2024, our inventory contains 21 lead, 25 galvanized requiring replacement, 409 unknown material, and 418 non-lead service lines.
